Notice of Race

1. Rules

- 1.1. The regatta will be governed by the "Rules" as defined in the Racing Rules of Sailing including appendix D. Races will be umpired.
- 1.2. The YNZ Safety Regulations Part 1 shall apply.
- 1.3. Sailing Instructions will be available at registration

2. Eligibility and Entry

- 2.1. To be eligible to compete in this event a competitor shall be a member of a club or other organization affiliated to the National Authority.
- 2.2. A Team will comprise of members only from one club. Composite teams will only be permitted if a club has less than 4 optimist sailors who have competed in an open fleet regatta or at the discretion of organisers.
- 2.3. The regatta will be open to Optimist boats only.
- 2.4. Entries will be accepted online at the KYC website.
- 2.5. There will be an entry fee of \$100.00 per team, payable online.

3. Schedule of Events

- 3.1. Registration from 7:30am until 8:45am
- 3.2. Briefing 8:45am
- 3.3. Time of first warning signal will be at 9:45am
- 3.4. The races will be sailed in the waters off Kohimarama Beach, Auckland
- 3.5. There will be no warning signal after 06:00pm

4. Course

- 4.1. Course to be sailed will be the standard teams racing 'S' course. The target time to complete the course will be ten minutes per race.

5. Trophy

- 5.1. The winning team will be awarded the "Inter Club Optimist Teams Racing Trophy"

6. Format

- 6.1. Racing will be conducted as round robin format. Details and racing schedule will be supplied along with sailing instructions at the briefing.

7. Agreement

- 7.1. By competing I agree to be bound by the Racing Rules of Sailing and all other rules that govern this event. I understand that yacht racing has inherent risks and dangers that are beyond the control of the organising authority. I understand that neither the organising authority and its officers, members and servants nor other persons assisting with the conduct of the regatta accept any responsibility in respect of any injury or loss to person or property that may be sustained by reason of participation in the regatta or howsoever arising in connection with the regatta. I agree to the use of my photograph(s) and other relevant information in any event publicity and in the ongoing promotion of New Zealand yachting.
