## NOTICE OF RACE

### 1.0 Rules

- 1.1 The regatta will be governed by the 'rules' as defined in the *Racing Rules of Sailing* 2013 - 2016.
- 1.2 Yachting New Zealand (YNZ) Safety Regulations Part 1 shall apply.
- 1.3 The Yachting New Zealand prescriptions that will apply are stated in Attachment 1.
- 1.4 The Yachting New Zealand Safety Regulations Part 1 shall apply. See Attachment 2. Notwithstanding the dispensation granted by Yachting New Zealand, sailboard competitors shall comply with clause 1.
- 1.5 For single-handed classes crew substitution will not be allowed.
- 1.6 Under rule 87, Changes to Class Rules, rule 7(a) of the Laser class rules is deleted and replaced by: The Laser shall be raced by one person aboard. The crew shall not change during the event.
- 1.7 For protests where only a rule of Part 2, When boats meet, or rule 31, Touching a mark, is alleged to have been broken an arbitration hearing may be offered prior to any formal protest hearing.
- 1.8 If there is a conflict of languages the English text will take precedence.

### 2.0 Changes to Racing Rules

The rules will be changed in accordance with rule 86 as follows:

Rule 61.1(a) will be changed so that boats will not be exempt from displaying a protest flag.

### 3.0 ADVERTISING

Boats may be required to display advertising chosen and supplied by the Organising Authority.

### 4.0 Eligibility and Entry

- 4.1 The regatta is open to female sailors of boats of the Optimist, P Class, Starling, Splash, Laser Radial, 420, Bic Techno and other Youth classes recognised by YNZ.
- 4.2 There will be an Optimist Green fleet.
- 4.3 There will not be age groups for the Optimist Open class.
- 4.4 Register on line at: [kyc.org.nz](http://kyc.org.nz) under Regattas  
Online entry fee is \$20.00 for single handed boats and \$30.00 for double handed boats.  
Additional sailors from the same family \$10.00
- 4.5 Late Entry Fee applies for entries received after 27th February 2013, of \$20.00 per family.
- 4.6 Measurement is not required. Measurement checks may be made.

### 5.0 Schedule of Events

## 5.1 Saturday 1 March 2014

Registration from 0830 to 0945 hours

Briefing 1000 hours

Warning signal race 1 1055 hours  
Races 2, 3 and 4 back to back.

A total of 4 races are scheduled.

5.2 Prize giving As soon as possible at KYC after the conclusion of the regatta.

## 6.0 **Sailing Instructions**

The Sailing Instructions will be available at Registration.

## 7.0 **Racing Area**

The races will be held on the waters off Kohimarama Beach, Auckland

## 8.0 **Courses to be Sailed**

The course(s) will be triangle or trapezoid or windward / leeward

## 9.0 **Scoring**

9.1 The Low-Points scoring system of Appendix A will apply.

9.2 Two completed races will be required to be completed to constitute a series.

9.3 No score will be excluded. This changes Appendix A2.

## 10.0 **Alternative Penalties**

10.1 Appendix N may apply.

10.2 Appendix P, Special procedures for Rule 42, may apply.

10.3 For the 420, 29er, 49er, 49er FX, SKUD 18, 2.4mR, Kiteboard, Access Liberty, Access 303, RS:X Boards and all multihull classes, rule 44,2 is changed so that the Two-Turns Penalty is replaced by a One-Turn Penalty

11.0 Spare

## 12.0 **Prizes**

Trophies and/or prizes will be awarded to the winner of each class provided there are four entries in that class. Other prizes may be awarded at the discretion of the Organising Authority.

## 13.0 **Team Support Boats**

Team Support boats will be allowed.

## 14.0 **Launching and retrieval**

All boats will be required to launch and retrieve from Kohimarama Beach.

## 15.0 **DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with, during or after the regatta.

## 16. **RIGHTS AND USE OF NAME AND LIKENESS**

By participating in the event, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for said event in which the competitor participated and in shall in all material related to the said event without compensation.

**20. DATA COLLECTION**

By entering this regatta you agree to share your details with our sponsors and receive information from time to time regarding their products.

**21. INSURANCE**

Each participating boat shall be insured with a third-party liability insurance with a minimum cover of NZL\$25,000 (recommend \$30,000) per event or equivalent.
