Notice of Race

Preamble: The Auckland District representative for the 2019 Starling Inter-Provincial Match Racing Championship which will be sailed at Glendowie Boating Club, will be selected at this regatta.

1.0 Rules

- 1.1 The regatta will be governed by the 'rules' as defined in the *Racing Rules of Sailing 2017-2020* including Appendix C (*Match racing Rules*).
- 1.2 The Yachting New Zealand (YNZ) Safety Regulations Part 1 shall apply.
- 1.3 The Organising Authority, Kohimarama Yacht Club (KYC), may require boats to Display the Regatta sponsor's advertising in accordance with Appendix 1, Regulation 20.3.1(d).
- 2.0 Changes to the definitions and the rules of Part 2
- 2.1 Changes to the definitions and the rules of Part 2 & 4 are set out in Appendix C2.
- 2.2 Rule C3.1 Start Signals is changed so that the warning signal will be made at 4 minutes and the preparatory signal will be made at 3 minutes before the start.
- 3.0 Spare

4.0 Eligibility and Entry

- 4.1 The regatta is open to boats of the Starling Class, that are registered with the Class Registrar, and hold an 'A' Certificate / are listed on the official Starling 3D jig-measured list of approved boats, and whose competitor is under 19 years of age on 31st January 2019 and who has been a financial member for the three months prior to the Regatta of a yacht club affiliated to YNZ that is within the Auckland District.
- 4.2 The Entry Fee will be \$40.00 per boat. Entries accepted on the KYC web site

Entries close Monday 12th November 2018 1800hrs.

Late entries, including late payments will not be accepted.

5.0 Schedule of Events

- 5.1 Measurement will not be required.
- 5.2 Registration: Saturday 17th November 2018 from 0800 hours to 0900 hours at the KYC clubhouse.
- 5.3 Briefing: Saturday 17th November 2018 at 0900 hours at the KYC clubhouse.

5.4 Racing Schedule:

- 5.4.1 The scheduled time of the first attention signal is 1000 hours.
- 5.4.2 The format of the event is match racing, scheduled as follows;
 - 5.4.2.1 Stage 1: Round Robin preliminaries
 - 5.4.2.2 Stage 2: Round Robin semi finals Optional
 - 5.4.2.3 Stage 3: Round Robin final
- 5.4.3 The number of matches to be sailed will be determined by the Organising Authority.
- 5.4.4 A Reserve Day is scheduled for Sunday 18 November 2018.
- 5.4.5 No match shall start after 1900 hours on a scheduled race day.

6.0 Sailing Instructions

Sailing Instructions will be available at Registration.

7.0 Racing Area

Races will be held in the waters off Kohimarama Beach.

8.0 Courses to be Sailed

Course(s) will be windward/leeward with starboard roundings, finishing downwind.

9.0 Scoring

Appendix C10 Scoring together with Appendix C11 ties will apply.

10.0 Alternative Penalties

Appendix C7 will apply

12.0 Prizes

The winner of the Regatta will be nominated as the Auckland District representative for the 2019 Starling Inter-Provincial Match Racing Championship. There are no further prizes.

13.0 Support Boats

- 13.1 Support boats will be allowed.
- 13.2 Support boats must be registered with the Organising Authority during registration.
- 13.3 Support boats shall remain stationary at any pre-start and shall remain 50 metres outside the race course area at all times, unless the Organising authority instructs otherwise.
